Primarily due to this continuous enrollment requirement over 94 million people enrolled in Medicaid or CHIP. Since the continuous enrollment requirement expired in April 2023 over 13 million Medicaid enrollees have been removed from the program. This panel will discuss state experiences for Medicaid redetermination, its ramifications for the future of the program, and other developments.
